THE OEC HAS BEEN COMMITTED TO PROTECTING OHIO'S WATER RESOURCES AND ADVANCING CLEAN ENERGY AND ENVIRONMENTAL JUSTICE ACROSS OUR STATE. WE LED INITIATIVES TO REPLACE LEAD SERVICE LINES AND ENHANCE REGULATORY PROTECTION EFFORTS THAT NOT ONLY SAFEGUARD PUBLIC HEALTH BUT ALSO YIELD SIGNIFICANT ECONOMIC BENEFITS. THROUGH SUPPORTING BOLD PROJECTS LIKE THE OAK RUN SOLAR PROJECT, WE CHAMPIONED RENEWABLE ENERGY SOLUTIONS THAT REDUCE CARBON EMISSIONS, CREATE CONSTRUCTION JOBS, AND PROMOTE SUSTAINABLE AGRICULTURAL PRACTICES. IN NORTHEAST OHIO, WE DROVE SUSTAINABILITY INITIATIVES IN AKRON AND HAVE SUPPORTED ENVIRONMENTAL JUSTICE WORK IN YOUNGSTOWN SECURING A MORATORIUM ON A POTENTIALLY HARMFUL PROJECT THAT THREATENED COMMUNITY WELL-BEING.
